Not only do People with Disabilities want to vote, <u>THEY CAN</u> and <u>DO</u> vote.



If you are a person with a disability or you know or support a person with a disability, this information is for **you**.

Did you Know?...



Many people don't vote because they think, "How can I?"

- ★ I don't know how to vote, I can't read.
- ★ I won't be able to get into the polls or cast my ballot.
- ★ I am not sure how government works.
- ★ The issue is confusing. I must not be smart enough to vote.
- ★ I have a guardian, I'm not allowed to vote.

In Delaware, having a guardian does not mean you can't vote. Even if you have a guardian, you can vote unless a court has said, in writing, that you can't.

People with disabilities <u>CAN VOTE</u> and they <u>ARE</u> participating in the voting process.

- ★ We are working to make voting accessible for everyone.
- ★ We are learning how legislation affects us and our community.
- ★ We understand how the government works.
- ★ We are sharing stories of when our vote made a difference.



It's time to make a difference and get involved!

- ★ Get to know the candidates.
- ★ Go to the polls and cast your ballot.
- ★ Ask for the support and accommodations that you need to vote.

Some facts to make the most of your voting opportunity:



REGISTER TO VOTE

The place where you vote must have your name on a list in order for you to vote. You can vote only if you are a registered voter. You can register to vote on-line at the following web address: https://ivote.de.gov/



ASK FOR A PROVISIONAL BALLOT

If they say no, you still have an option! If the poll worker says you cannot vote for <u>any reason</u>, remember these words... "Please give me a Provisional Ballot." It is a temporary ballot that anybody can use (in elections for federal offices) so you don't miss a chance to vote while they are checking to see if you can.



GET GOOD HELP

Support is your choice. You can ask the poll workers for help to vote and they are supposed to assist you. Some people find it is best to bring an assistant who knows the kind of help you need. Examples might be reading, pushing buttons or writing. Your vote is your voice in our government, so this person <u>must</u> respect and trust your decisions and not tell you who or what to vote for.



CHANGE ADDS UP!

What if something does not go well? You can file a complaint with the Delaware Office of the State Election Commissioner, 302-739-4277. You can be a part of the solution.
