### WHO WE ARE

Community Legal Aid Society, Inc. (CLASI) is Delaware's oldest and largest civil legal aid organization and is one of the oldest civil legal aid programs in the United States. Our mission is to combat injustice through creative and persistent civil legal advocacy on behalf of vulnerable and underserved Delawareans. We have over 70 staff members working in three offices across the state: Wilmington, Dover, and Georgetown.

## WHAT WE DO

CLASI is an unrestricted (non-LSC funded) civil legal aid program. We have a range of vibrant programs and units that assist low-income and marginalized clients:

- Disabilities Law Program
  - Delaware's designated Protection and Advocacy system for people with disabilities
- Medical-Legal Partnership Program
  - Partnering with health and social service providers statewide

- Elder Law Program
- Fair Housing Program
- Domestic Violence Unit
- Housing Unit
- Immigration Unit
- Public Benefits Unit

In addition to providing individual representation, as an unrestricted program CLASI is able to work for systemic change through impact litigation, community education, and legislative and policy advocacy on the state and national level.

### **OUR IMPACT**

In 2022, CLASI handled 6,303 cases, assisting 11,289 individuals and family members across the state. We also have a long track record of taking on some of the biggest systemic challenges facing low-income and vulnerable Delawareans. We've protected the rights and improved the lives of tens of thousands of people through our law and policy reform efforts. For example, in the past several years we:

- Led coalition that in 2023 won passage of historic "right to representation" legislation for low-income renters facing eviction, making Delaware only the fourth U.S. state to provide this critical right
- Settled landmark school funding lawsuit against the state resulting in major improvements in funding for children in high poverty schools, children with disabilities, and English language learners
- Won significant court appeal regarding the scope of the Delaware Equal Accommodations Law, creating momentum for new legislation that we helped draft which now explicitly requires places of public accommodation to make reasonable accommodations for people with disabilities
- Settled groundbreaking litigation against the Delaware Department of Correction, dramatically overhauling the state's solitary confinement system and increasing therapeutic and behavioral services for inmates with mental illness
- Led on national rulemaking efforts resulting in billions in student loan debt being forgiven for people with disabilities
- Helped lead coalition that won passage of paid family and medical leave legislation in Delaware
- Secured important protections from excessive lot rent increases for manufactured housing homeowners who live in rental communities

### **OFFICE CULTURE**

CLASI is a diverse, inclusive, collaborative, and progressive workplace, and we are proud of our supportive, collegial work environment. Our passionate, mission-driven attorneys are experts in their fields. They are deeply committed to our clients and to mentoring the next generation of public interest attorneys. We provide extensive training and professional development opportunities to our staff.

CLASI was recognized as a Delaware "Top Workplace" in 2023 for the seventh time, based on an independent workplace culture survey of our employees. Our staff has doubled from 36 to over 70 in just the past seven years, as we continually seek to grow and innovate to meet the most pressing legal needs in our state.

### **EMPLOYEE BENEFITS**

CLASI is a unionized program with a bargained salary scale. The current entry-level salary is \$59,891 for attorneys, scaled based on prior relevant experience. We also offer excellent benefits, including:

- Health and dental insurance for employees and their immediate family (including domestic partners) with premiums for the base plan fully funded by CLASI
- Vision, short and long-term disability insurance, and life insurance at no cost to employees
- Generous annual and health leave time
- 14 paid holidays and 4 personal days
- 403(b) retirement plan, with CLASI contributing an amount equal to 10% of the employee's salary when they contribute at least 1% (eligible after one year, vested after three)
- Hybrid work options
- Law school loan assistance payment plan of up to \$250 per month funded by CLASI
- Access to Public Attorney Student Loan Repayment Assistance Program providing up to \$5,000/year in assistance funded by the state (eligible to apply after one year at CLASI)
- Unique bar exam preparation program providing 10 weeks of paid time off to study for the Delaware Bar and a CLASI attorney mentor providing individual advice and support
- All costs associated with applying, studying, and sitting for the Delaware Bar Exam and maintaining Delaware Bar membership, including all CLE courses, professional development, training, and conferences
- Free parking and reimbursement for any work-related travel
